## WHAT:

Asolo Rep's *A DOLL'S HOUSE, PART 2* IllumiNation event will be held on Wednesday, March 6. A stimulating series of theatre and conversation exploring the topical and social themes threaded throughout the season, IllumiNation events begin one hour prior to curtain with a ticketed reception on the mezzanine, continue with the performance, and conclude with a free, open-to-the-public conversation.

The panel for *A DOLL'S HOUSE, PART 2* IllumiNation event will be moderated by **Christine Burton**, a former public school educator and senior administrator from New York, who is also a past participant of Asolo Rep's Faces of Change program. The panel features **Freya Robbins**, a Florida Supreme Court Certified Family Mediator, and **Jackie Simmons**, Founder of Success Journey Academy and the Empowering Women Network.

For each IllumiNation performance, a block of seats will be held in the mezzanine and balcony for PAY WHAT YOU CAN (minimum of \$5 per ticket). These tickets can only be reserved on the day of the show starting at 10am by phone or at the box office.

## WHO:

Christine Burton (moderator): A former public school educator and senior administrator from New York, Christine Burton has lived on Florida's west coast since 2012. Christine's recent background includes nonprofit work as an advocate for survivors of domestic and sexual violence, and as a grant writer and consultant developing programs serving the homeless. With degrees in education, school leadership and applied anthropology, she is in the final stages of her dissertation at Columbia University for her doctorate. Christine has previously participated in Asolo Rep's Faces of Change and community engagement programs.

**Freya Robbins**, Zollinger Mediation: As a Florida Supreme Court Certified Family Mediator, Freya provides marital mediation, eldercare mediation and divorce mediation. Freya offers an alternative to traditional marriage counseling for couples who are experiencing conflict in marriage by equipping couples with tools for improved communication, more effective parenting and co-parenting, and better management of family finances. Freya is a known advocate in eliminating Childhood Sexual Abuse and serves on the Advisory Board of the Child Protection Center in Sarasota, FL.
